This is a contract between Tradewinds Quarter Horses, LLC, (hereinafter called “Kennel”) and the pet owner whose signature appears below (hereinafter called “Owner”).

1. Kennel agrees to exercise due and reasonable care to keep its premises sanitary and properly enclosed. Kennel hereby discloses that there is a known presence of potentially harmful or lethal pests in the area against which kennel enclosures are ineffective (including but not limited to rats, toads, ticks, centipedes, scorpions, mongoose, owls, etc.), and owner agrees that Kennel shall not be held responsible for any liability with respect to the animal/s listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from boarding this or any future animal.
2. Owner agrees to pay the rate for boarding in effect on the date pet is checked into the Kennel and further agrees to pay all costs and charges for special services requested and for all veterinary and transportation costs for the pet during the time said pet is in the care of the Kennel. Balances not paid within 30 days are subject to re-billing fees of 18% APR (.015/month), min. \$25 fee/month.
3. The Kennel does not assume and shall not be held responsible for any liability with respect to the animal/s listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from boarding this animal, or any damages which may accrue from any other cause whatsoever including loss by fire, theft, running away, death, injury to persons, animals or property, or death or injury to any other animal caused by the within named animal/s during the term of this contract, whether this animal be on the premises of the Kennel or not, and the owner of said animals agrees hereby to be and is solely responsible for any and all acts of behavior of said animal/s at any time within the term and time of the contract. The responsibility and/or liability of the Kennel, in no event shall exceed the sum of Two Hundred Dollars (\$200.00) and the undersigned agrees to limit the responsibility to Two Hundred Dollars (\$200.00) for any and all damages sustained or suffered by reason of the boarding of this animal/s and said Kennel to the sum of Two Hundred Dollars (\$200.00) and no more, and agrees not to claim any damages against said Kennel of any nature whatsoever, either by way of contract, equity, negligence or otherwise, in excess of said sum.
4. Owner specifically represents that within named animal/s have not previously shown signs of aggression towards other animals or people, and owner agrees to be fully responsible and liable for all acts or behavior of said animal/s while in the care of the Kennel. Owner represents that s/he is the sole owner of said animal/s there is not now any lien or mortgage against said animal/s.
5. Guests are charged for their date of arrival, regardless of what time they check in. Check-out time is 10 a.m. Guests who depart after 10 a.m. will be charged for the departure day.
6. Prior to their first stay, all dogs must complete a pre-boarding visit and assessment at the kennel. Upon approval of the staff, reservations will only be confirmed upon receipt of a completed and signed boarding agreement, the required veterinary records, and a non-refundable deposit of 50 percent of the estimated boarding fees. The remaining fees are due at check-in time.
7. The Kennel shall have, and is hereby granted, a lien on the animal for any and all unpaid boarding and/or other charges resulting from the boarding of said animal/s with the Kennel. If Owner fails to pay all charges and/or claim said animal/s within 3 days of scheduled pick-up, Kennel has the right to sell said animal/s or otherwise dispose of it/them, at its discretion. Owner agrees to pay at double the daily boarding rate for each day after scheduled pick-up.

8. The owner does hereby entrust the Kennel to care for said animal/s and authorizes the Kennel to perform whatever it deems necessary for the health and well-being of the animal. Owner authorizes Kennel to take animal to the veterinarian of its choice and agrees to pay for any and all expenses relating to the animal's care, transportation, and board. Owner agrees to hold Kennel harmless for any illness, accident, or injury and agrees that Owner is solely responsible for any and all damages that animal may cause to the kennel, attendants, other animals, guests, or itself.
9. While the Kennel will exert its best effort to avoid accidents and illness, they do sometimes occur. In the event of a life-threatening situation, and we cannot reach the Owner, please check the decision below that you would prefer for your pet:

10. The Kennel reserves the right to use Citronella or sonic devices in the event of excessive barking.
11. In the event of undesirable pet behaviors, including, but not limited to, signs of aggression, separation anxiety, excessive barking, or destructive behaviors, etc., Kennel may need to "crate" the guest. If this does not solve the problem, kennel will notify Owner by telephone or e-mail and request that Owner promptly remove pet from Kennel premises. If Owner is unavailable, Owner agrees to designate a representative to promptly remove pet. Prepaid boarding fees for unused days will be refunded to Owner. "Undesirable behaviors" shall be defined solely by Kennel.
12. Any controversy or claim arising out of or relating to this contract shall be settled by arbitration in accordance with the rules of the American Arbitration Association. The arbitrator shall, as part of his award, determine an award to the prevailing party of the cost of such arbitration, reasonable attorney's fees of the prevailing part.
13. This Contract contains the entire agreement between the parties, and all terms and conditions will be in effect for this and all future boardings at the Kennel. Any changes to this contract must be agreed to in writing by both parties. All terms and conditions of this agreement shall be binding on the heirs, administrators, and assignees of the owner of the within named animal/s.

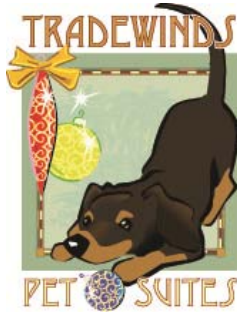
